Packing etc.: The following was checked without remarks: The company's GMP procedures. The following procedures were checked: Withdrawal, receipt of goods and control of finished goods. Obtaining and forwarding of documentation were checked. No remarks.

The following was checked without remarks: Certificate of conformity from supplier of fitting (PEEK), including identification of the product, information on use (type of food, time and temperature), information on substances with specific migration limits and dual use additives, issuer of declaration and signature. The following was found: The company has prepared a certificate of conformity for cooling machine. It was verbally stated that this machine contains plastic parts. From the certificate of conformity information on identification of the product, information on use (type of food, time and temperature), information on substances with specific migration limits and dual use additives do not appear. In the present circumstances this is considered a minor violation. Guidance about rules for the contents of certificate of conformity for plastic materials cf. appendix 4 in the Plastic Regulation was given.

Approvals etc.: The following was checked without remarks: VAT number.

Packing etc.: Checked certificate of conformity for steel from supplier and certificate of conformity for customers for machine comprising steel and plastic. The following was found: From the certificates of conformity for steel parts for the machines compliance with 2023/2006 does not appear. From the certificate of conformity for machine parts and spare parts the type of plastic used as well as type of food and temperature do not appear.

In the present circumstances this is considered a minor violation.

General guidance about rules for the contents of certificates of conformity was given.

The following was checked without remarks: Certificate of conformity from supplier of plastic parts (pom c) for machine, including identification of the product, information on use (type of food, time and temperature), information on substances with specific migration limits and dual use additives, issuer of declaration and signature.

The following was checked without remarks: Traceability on parts for machine via invoice.

The following was checked without remarks: The company's GMP procedures.

The following procedures were checked: Withdrawal and reception of goods as well as maintenance of evidence that specifications, production regulations and processes relevant for the final material are in compliance with the rules.

The following was checked without remarks: Background documentation for steel intended for food contact.

Packing etc.: Checked the traceability one step backwards for stop flange cylinder p150 (stainless steel, aisi 316) and went through the company's procedure for traceability. According to the company, traceability may be possible two or three steps backwards. No remarks.

The following was controlled without remarks: The company's GMP procedures.

The following procedures were controlled: Purchase of parts for the machine and requirements to the manufacturer, withdrawal and obtaining of specifications from the supplier. No remarks.

Carried out spot checks of declaration of conformity from the supplier of stainless steel. The supplier states observance of the 1935/2004 for all materials manufactured for the company. No remarks. The statement does not contain information on type of material (f.inst. type of steel), statement of observance of regulation 2023/2006, date of issue of the statement as well as name and signature. The company has confirmed that contact will be made to the supplier.

Carried out spot checks of declaration of conformity for the plastic part pom c (scraping knife). This included information on use (type of food, time and temperature), information on ingredients with specific migration limits and dual-use additives, issue of declaration and signature. No remarks.

The following was checked without remarks: The company's declaration of conformity for food contacting material for the customers. The following food contacting material was checked: Scraped surface heat exchanger to produce crystallised emulsions.
